Know all men by these presents that we the undersigned legatees of Elizabeth Bower, late of East Hempfield Township in Lancaster County deceased do hereby acknowledge that we have this day had and received of and from Jacob Bower, Executor, of the will of said deceased the following sums of money to wit:

John Bower, one of the son's deceased nephews and son of her brother Jacob received six hundred and fifty one dollars 41 cents (\$651.41).

Frederick Sener in the right of his wife Anna, late Anna Bower, one of the six children of the deceased's nephew, Abraham Bower received one hundred and eight dollars 57 cents (\$108.57).

Adam Dietrich Jun. guardian of John and Abraham Bower, minors, two of said six children of Abraham Bower received for each of his said wards one hundred eight dollars 57 cents (\$108.57).

John Bower, guardian of Michael, Mary and Leah Bower, minors, three of the six children of said Abraham Bower, received for each of his said wards one hundred eight dollars and 57 cents (108.57), each,

and every of us John Mumma, Jacob Mumma, Christian Mumma by his attorney in fact John K. In full satisfaction and payment of all our our (sic) wives and our wards shares parts and interests under said Elizabeth Bower's will of in and to the sum of six thousand one hundred and seventy one dollars 23 cents (\$7171.25), the balance which remained in said executor's hands of all the deceased testatrix's estate after the legal deductions, according to his account of the same exhibited unto the registers office in Lancaster on 12 February 1847 and after deducting the tax upon the same as a collateral inheritance and the specific legacies; therefore we release acquit and forever discharge the said Jacob Bower executor aforesaid his heirs executors and administrators of and from all our own wives and our wards shares, parts and interests of and in all said deceased estate aforesaid and all interest accrued and of and from all actions suits accounts reckonings claims and demands respecting the same.
