## Will of Elizabeth Bauer

Elizabeth Bauer – Deceased }

In the name of God, Amen. I Elizabeth Bauer, of East Hempfield Township, in Lancaster County, Pennsylvania, being in health of body and sound mind and memory, for which I thank GOD my Saviour: do make and publish this my last Will and Testament in manner following:

I direct all my just debts and funeral expensed to be paid as soon as conveniently can be done.

Owning in common with my sister Catharine the furniture, goods and effects in this house in which we live, I give and bequeath my half and share thereof to my said sister Catherine, if living at my death and at her death I give and bequeath the same half of said furniture, goods and effects unto my nephew, Jacob Bauer if then living and in case he be then dead, I give and bequeath the same to the children who he may have – And if my said sister die before my death, the said goods, furniture and effects, shall at my death go and pass to the said Jacob, if living or to his children if he be dead.

I give and bequeath to each of the two children of my brother John Bauer deceased, the sum of five hundred dollars.

All the rest, residue and remainder of my estate, outstanding moneys, cash, etc. I direct to be divided into three equal parts:

One equal third part of said third I give and bequeath to each of my nephews, Jacob and John Bauer, two of the children of my deceased brother, Jacob Bauer.

And the remaining equal third part of said third I give and bequeath to the children of my deceased nephew, Abraham Bauer in equal shares.

One other equal third part of the residue of my estate I give and bequeath to my brother Christian Bauer, if he be living and if dead, to the children whom he may leave or have left in equal shares.

And the remaining equal third part of the residue of my estate I give and bequeath to the children of my deceased sister, Susanna Mumma in equal shares.

If any of my legatees are dead or shall die before my death, their legacies shall not lapse, but go their right heirs.

And lastly I nominate, constitute and appoint my nephew, Jacob Bauer of East Hempfield Township to be the Executor of this my Last Will and Testament.
